## **Consent for Medical Treatment Under Texas Law and Patient rights:**

AGREEMENT AS TO GOVERNING LAW AND FORUM: The patient (including the patient's representative, heirs or beneficiaries) and the health care providers at Alamo Asthma & Allergy rendering or providing medical care, or professional services directly related to health care to patient (including employees and agents of AA & A) agree:

- 1) That all health care rendered shall be governed exclusively and only by Texas Law and in no event shall the law of any other state apply to any health care rendered to patient; and
- 2) In the event of a dispute, any lawsuit, action, or cause of which in any way relates to health care provided to the patient shall only be brought in a Texas Court in the county / district (Bexar) where all or substantially all, of the health care was provided or rendered and under no circumstance will any lawsuit, action or cause of action, ever be brought in any other state.
- 3) A patient has a right to request a notation be added to their Medical Record concerning any content they believe is incorrect.
- 4) A patient has the right to request Medical Information be transmitted to them by: mail, phone or fax, but not by e-mail: unless two-way encryption is available.
